The closing date of the competition is Friday 23 August 2013. Any entries submitted after this date will not be considered for acceptance. Entry is free.
4. Matatiele Local Municipality will not accept responsibility for any competition entries that are lost, damaged, unreadable or incorrectly completed.
5. Matatiele Local Municipality has the right at any time to require proof of identity and/or eligibility. Failure to provide such proof could result in disqualification from the competition. All personal details and information supplied by each participant must be truthful, accurate and in no way misleading. Matatiele Local Municipality reserves the right to disqualify any participant from the competition or auditioning process in its sole discretion, should the contestant at any stage supply untruthful, inaccurate or misleading personal details and/or information.
6. By submitting a competition entry, participants agree that their photograph/Video and name may be used for promotional purposes in any medium of advertising relating to this competition.
7. Participants will be notified in due course of their audition times and venue. Matatiele Local Municipality shall not be held responsible for incorrect or unreadable telephone or email details, or any inability to contact the participant on the number or address supplied.
