- 1.3 Certified copies of BBBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit. Failure to submit will result in zero points score for BBBEE status level.
- 1.4 Authority to sign section must be signed and completed in full.
- 1.5 Copies of ID Documents and all submitted certificates must be certified
