Requirements for sealing, addressing, delivery, opening and assessment of Quotations are stated in the Quotation Data.

**B. BID EVALUATION**

**This bid will be evaluated in three (3) phases as follows:**

<b>Phase</b>	<b>Description</b>
Phase One (1)	Bidders will be evaluated on compliance, responsiveness to the bid rules and conditions.
Phase Two (2)	Bidders passing stage one above will thereafter be evaluated on functionality, thereafter.
Phase Three (3)	Bidders passing all stages above will thereafter be evaluated on PPPFA.

**Functionality Evaluation:**

A minimum total score of **48** points out of **80** points (**60%**) must be scored for functionality to qualify for further evaluation. The applicable functionality criteria are as follows:

<b>Functionality Criteria</b>	<b>Maximum Points Score</b>
i) Road Contract Management Experience	30
ii) Technical Expertise	20
iii) Locality	30
<b>Maximum Possible Score for Functionality</b>	<b>80</b>

**C. PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT (PPPFA)**

Points will be awarded as follows:

Maximum points on price	-	<b>80 points</b>
Maximum points for BBBEE	-	<b>20 points</b>
Maximum points	-	<b>100 points</b>
