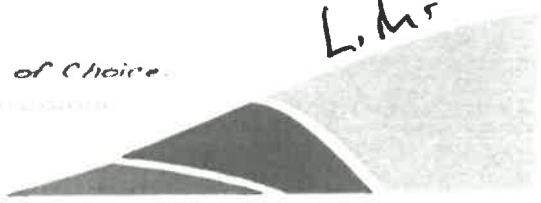

Only bidders who obtain 90 points as a minimum functionality threshold will be evaluated further on 80/20.
